We are pleased to enclose your Certificate of Registration as a person authorized to solemnize marriages in the Province of Ontario.

Under the provisions of the Marriage Act, certain duties and obligations are imposed on you. It is your responsibility to become familiar with them, especially Sections 17, 18, 27 and 28 of the Act and Subsection 2(3) of Regulation 738. These sections explain the requirements respecting publication of banns, the 3-day waiting period, recording essential data and reporting in detail.
